

# **HURONIA DISTRICT SOCCER ASSOCIATION & APPEALS COMMITTEE**

## **RIGHTS OF APPEAL INFORMATION**

You have the right to appeal the decision of the Simcoe County Youth Soccer League.

This decision may be appealed to HURONIA DISTRICT SOCCER ASSOCIATION DISCIPLINE AND APPEALS COMMITTEE and may be appealed by any party affected by the decision.

The letter of appeal must specify your rationale for appealing the decision of the Simcoe County Youth Soccer League. Your rationale must include:

- a) New facts not available when the Simcoe County Youth Soccer League decision was made or not available at previous hearings; OR
- b) Specific procedural errors made by the Simcoe County Youth Soccer League or at previous hearings; OR
- c) Specific instances where Articles or Rules have been wrongly interpreted by the Simcoe County Youth Soccer League or at previous hearings; OR
- d) Alleged excessive fine, fee, bond or suspension.

Failure to provide adequate rationale will result in your appeal being disallowed.

The appeal must be submitted in writing by registered mail or recognized Courier Service or by hand-delivery or by fax or by e-mail to:

When registered mail or recognized Courier Service is used to submit the appeal, it must be postmarked or dated no more than five (5) working days from the receipt of the written decision rendered by the Simcoe County Youth Soccer League. When hand-delivery, fax or e-mail is used to submit the appeal, it must be received at the Huronia District Soccer Association office no later than five (5) working days from the receipt of the written decision rendered by the Simcoe County Youth Soccer League. In cases of disputed delivery date regarding appeals submitted by hand-delivery, fax, or email, it is the responsibility of the Appellant to prove which date that the appeal was received at the HDSA office.

A copy of the letter of appeal may be sent by registered mail or recognized Courier Service or by hand-delivery or by fax or by email to this Simcoe County Youth Soccer League at its address below:

However, it is the responsibility of the Governing Organization (ie: in this case HDSA Discipline and Appeals Committee) to advise all relevant parties about the appeal and to provide them with a copy of the appeal.

The appeal to the HDSA Discipline and Appeals Committee must include:

1. a letter of appeal
2. the appeal fee of two hundred dollars(\$200.00) by certified cheque or money order for appeals by clubs, leagues, or other organizations, OR
3. the appeal fee of one hundred dollars (\$100.00) by certified cheque or money order for appeals by individuals
4. a copy of the decision being appealed

If the appeal is upheld, the appeal fee will be returned to the appellant.

Special criteria are used in the deciding of appeals pertaining to playing out rights. Contact the HDSA Office for more information on appeals for playing out rights. For additional information about appeals, call the HDSA at 705-739-6729
