Failure to comply will result in an automatic 20 points to be applied to the Club.				
HOME CLUB is responsible for submitting the both game sheets, by mail, faxed, email or hand delivery, to the convenor within 3 days following completion of the match. Failure to comply will result in an automatic 10 points being applied to the Home Club, as set out in the Points System. Failure to submit the game sheet by the 15th calendar day, from date of game will result in the automatic loss of any points, if earned.

Team Jersey's ..In the event of a colour clash, the HOME team must change its shirts. Failure to comply with the referee's decision will result in a game forfeit to the HOME TEAM.				
Game Length & Ball Size:				
U9 & U10 - 25 minute halves - size 4 ball				
U11 & U12 - 35 minute halves - size 4 ball				
U13 & U14 - 40 minute halves - size 5 ball				
U15 & up - 45 minute halves - size 5 ball				
A valid game is when 2/3rd plus one minute of game has elapsed. If the referee calls a game, must be put on the gamesheet as to the reason the game was called and the time that the game was called at. If it is not marked on the gamesheet, the game will be considered a valid game and no protest will be allowed. Any team not showing up before the twenty minutes of grace has elapsed following the determined kick off time, will default the game to its opponent.				
Substitutions: in the mini divisions, players changes may be on any stoppage of play when the ball has left the playing field. All other divisions can change players only on a goal, goal kicks, injury, half time or on your own team's throw-in with the ref's permission.
